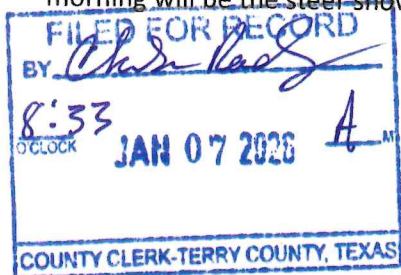
- Call Meeting to Order if a quorum is present.
