



## NOTICE OF MEETING OF THE COMMISSIONERS COURT OF TERRY COUNTY, TX.



- Pledge of Allegiance to the American and Texas flag.


### DELIBERATE AND CONSIDER ACTION ON THE FOLLOWING ITEMS:


