The Court Orders that each case on this docket is set as follows:


1. **Status / Pre-Trial Hearing: November 25, 2025 at 9:00 a.m. in the Terry County District Courtroom**

Plea Bargain: Unless good cause is shown, the deadline to announce acceptance and request a setting by submission of a Plea Request Form on a negotiated plea of guilty, is 21 days prior to the Jury Trial Date.
