

Each case is set for a Trial Conference on the above date. This date is the **DEADLINE** to announce acceptance and request a setting on a negotiated plea of guilty. The order of trial will be set after the last Trial Conference. You are excused from the appearance for this setting, if a plea request form has been submitted
3. **Jury Trial: November 12, 2024 at 9:00 a.m. Jurors will report at 9:00 a.m.**
Each case is set for Jury Trial on the above date. If the case is not resolved by a plea, trial or otherwise the case will be reset for jury trial on a subsequent docket.
