

3. Jury Trial: November 12, 2024 at 9:00 a.m. Jurors will report at 9:00 a.m.

Each case is set for Jury Trial on the above date. If the case is not resolved by a plea, trial or otherwise the case will be reset for jury trial on a subsequent docket.
