
JURY TRIAL FOR CRIMINAL CASES. The Defendants and Attorneys are ORDERED to personally appear at the setting for Pre-Trial hearing and Jury Trial, that applies to their case, unless excused in advance by the court. Failure of Defendant to appear will result in forfeiture of bail.

The Court Orders that each case on this docket is set as follows:

1. **Pre-Trial Hearing: June 10, 2025 at 9:00 a.m. in the Terry County District Courtroom**
Each case is set for a Pre-Trial hearing on the applicable date above, pursuant Tex. Code Crim. Proc. Art. 28.01. You are excused from the appearance for this setting, if a plea request form has been submitted. It is the responsibility of the Movant to obtain a hearing date for any Motion to Continue, filed after the Pre-Trial hearing setting.
2. **PLEA DEADLINE: July 8, 2025 at 9:00 a.m.**
This date is the **DEADLINE** to announce acceptance and request a setting on a negotiated plea of guilty. The order of trial will be set after this date. All announcements are due by 9:00 a.m. on July 8, 2025 at jadidway@terrycounty.org and lcampos@terrycounty.org.
3. **Jury Trial: August 11, 2025 at 9:00 a.m. Jurors will report at 9:00 a.m.**
Each case is set for Jury Trial on the above date. If the case is not resolved by a plea, trial or otherwise the case will be reset for jury trial on a subsequent docket.
