2. **Trial Conference:** May 12, 2026 at 9:00 a.m. in the Terry County District Courtroom  
Each case is set for a Trial Conference on the above date. The order of trial will be set after the last Trial Conference. If a plea request form has been submitted, you are excused from the appearance for this setting,
3. **Jury Trial Date:** June 15, 2026 at 9:00 a.m., in the Terry County District Courtroom. Jurors will report at 9:00 a.m.  
Each case is set for Jury Trial on the above date. If the case is not resolved by a plea, trial or otherwise the case will be reset for jury trial on a subsequent docket.

**Plea Bargain:** Unless good cause is shown, the deadline to announce acceptance and request a setting by submission of a Plea Request Form on a negotiated plea of guilty is 21 days prior to the Jury Trial Date.
