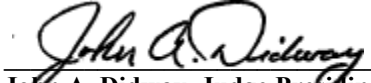

The Court Orders that each case on this docket is set as follows:

1. **Pretrial/Status Hearing: September 30, 2025 at 9:00 a.m. in the Terry County District Courtroom**
Each case is set for a pretrial hearing on the applicable date above, pursuant Tex. Code Crim. Proc. Art. 28.01. You are excused from the appearance for this setting, if a plea request form has been submitted. It is the responsibility of the Movant to obtain a hearing date for any Motion to Continue, filed after this pretrial hearing setting. The order of cases will be set after this setting.
2. **Jury Trial: November 3, 2025 at 9:00 a.m., in the Terry County District Courtroom. Jurors will report at 9:00 a.m.**
Each case is set for Jury Trial on the above date. If the case is not resolved by a plea, trial or otherwise the case will be reset for jury trial on a subsequent docket.
