

- 2. <u>Jury Trial:</u> November 3, 2025 at 9:00 a.m., in the Terry County District Courtroom. Jurors will report at 9:00 a.m. Each case is set for Jury Trial on the above date. If the case is not resolved by a plea, trial or otherwise the case will be reset for jury trial on a subsequent docket.
