1. Pretrial/Status Hearing: October 28, 2025 at 9:00 a.m. in the Terry County District Courtroom

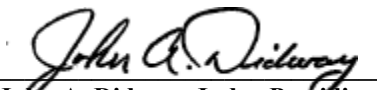
