The Court Orders that each case on this docket is set as follows:

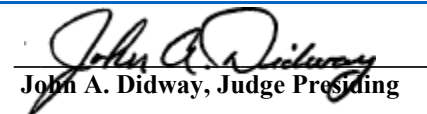
1. **Status / Pre-Trial Hearing: July 21, 2026 at 9:00 a.m. in the Terry County District Courtroom**
Each case is set for a Pre-Trial hearing on the applicable date above, pursuant Tex. Code Crim. Proc. Art. 28.01. You are excused from the appearance for this setting, if a plea request form has been submitted.
2. **Trial Conference: August 18, 2026 at 9:00 a.m. in the Terry County District Courtroom**
Each case is set for a Trial Conference on the above date. The order of trial will be set after the last Trial Conference. If a plea request form has been submitted, you are excused from the appearance for this setting,
3. **Jury Trial Date: September 21, 2026 at 9:00 a.m., in the Terry County District Courtroom. Jurors will report at 9:00 a.m.**
Each case is set for Jury Trial on the above date. If the case is not resolved by a plea, trial or otherwise the case will be reset for jury trial on a subsequent docket.

Plea Bargain: Unless good cause is shown, the deadline to announce acceptance and request a setting by submission of a Plea Request Form on a negotiated plea of guilty is 21 days prior to the Jury Trial Date.
